



## Supplemental Summary for FY 2015 Annual HUB Report for Agency 576

The Texas A&M Forest Service (TFS) is committed to making a Good Faith Effort to assist Historically Underutilized Businesses (HUBS) in the procurement process in accordance with the goals and rules established by state statute. The procurement process seeks to provide equal access to all businesses, encourage competition and promote other fair business practices.

### In Reach Program

Agency personnel are offered assistance in identifying HUB Vendors throughout the year while the HUB Coordinator participates in TPASS HUB Cooperative meetings, Statewide HUB Discussion Workgroup meetings, the TAMUS HUB Coordinator meetings (TUHCA) and system wide HUB specialized forums, which all provide opportunities for agencies to benefit from other member agencies' strategies and experiences.

### Out Reach Program

TFS attended and/or exhibited at eight (8) Economic Opportunity Forums throughout the state—the University of Houston HUB Expo in Houston, TX on October 8<sup>th</sup>, the Stephen F. Austin Vendor HUB fair in Nacogdoches, TX on October 30<sup>th</sup>, the Bexar County, SMWVBO EOF in San Antonio on December 10<sup>th</sup>, the 2015 Procurement Connection Seminar & HUB Expo at the Ford Park Center in Beaumont on February 19<sup>th</sup>, the Sam Houston State HUB Vendor Show in Huntsville on March 24<sup>th</sup>, the University of Houston HUB Vendor Show in Houston on April 15<sup>th</sup>, the States Spot Bid Fair in Irving on May 11<sup>th</sup> & 12<sup>th</sup> and the HUB vendor show in Austin at the Renaissance hotel on July 29<sup>th</sup>.

### Impediments

The State of Texas Retail Fuel Purchase Contract is not a Term Contract it remains identified only as a CCG Contract. All state agencies and higher education are required by law to utilize the State's fuel contract therefore not allowing any opportunity to award this purchase category to HUB Vendors. For fiscal year 2015, this was a **\$1,141,329.43** impediment against our HUB efforts.

As an Emergency Response Agency, a substantial amount of the agency's procurements are for highly specialized equipment and services required to support agency operations in wildfire suppression/prevention, forest development, and other forestry related operations. TFS continues to experience an inadequate amount of HUB vendors that can actually bid on and supply these specialized items. For FY15, the TFS agency has spent over **\$5,500,000** on heavy equipment purchases.
