### Who Must File

Every licensed supplier, permissive supplier, distributor, or distributor/aviation fuel dealer must report sales of tax-free dyed diesel fuel to a purchaser with a signed statement on this schedule. Failure to file this schedule may result in collection action as prescribed by Title 2 of the Tax Code.

#### **Specific Instructions**

- Item 1 Enter the name of the purchaser.
- Item 2 Enter the three-digit product type. 228 - Dyed Diesel Fuel 072 - Dyed Kerosene.
- Item 3 Enter the purchaser's signed statement number with either an "AG" or "DD" prefix.
- Item 4 Enter the total invoiced gallons sold to the signed statement holder for the month.
