## Instructions for Completing Texas Sulphur Production Tax Report

### Who Must File -

Every person (sole owner, partnership, corporation or other organization) that is responsible for payment of the Sulphur Production Tax must file this report. Complete and detailed records must be kept.

### When to File -

Reports must be filed on or before the last day of the month following each reporting period. If the due date falls on a Saturday, Sunday or legal holiday, the next business day will be the due date. A report must be filed for every calendar quarter even if no tax amount is due.

### General Instructions -

- If any preprinted information is not correct, mark out the item and write in the correct information.
- TYPE OR PRINT.
- Do not write in shaded areas.

### Specific Information -

**Item 5 - PENALTY:** If you file the report or pay the tax after the due date, enter penalty. If 1-30 days late, enter 5% of Item 4. If more than 30 days late, enter 10% of Item 4.

**Item 6 - INTEREST:** If any tax due is unpaid 61 days after the due date, enter interest on the amount in Item 4 at the rate published on Pub. 98-304, online at [www.comptroller.texas.gov](http://www.comptroller.texas.gov) or at 1-877-447-2834.
