Instructions for Completing Texas Cement Production Tax Report

Who Must File -

Every person (sole owner, partnership, corporation or other organization) that manufactures or produces cement in Texas and/or imports cement into Texas for distribution, sale or use within the State must file this report. Complete and detailed records must be kept.

When to File -

Reports must be filed on or before the 25th day of the month following each reporting period. If the due date falls on a Saturday, Sunday or legal holiday, the next business day will be the due date. A report must be filed for every month even if no tax amount is due.

- If any preprinted information is not correct, mark out the item and write in the correct information.

- TYPE OR PRINT.

Specific Information -

<u>Item 5</u> - PENALTY: If you file the report or pay the tax after the due date, enter penalty. If 1-30 days late, enter 5% of Item 4. If more than 30 days late, enter 10% of Item 4.

<u>Item 6</u> - INTEREST: If any tax due is unpaid 61 days after the due date, enter interest on the amount in Item 4 at the rate published on Pub. 98-304, online at www.comptroller.texas.gov or at 877-447-2834.
